Prof. Dr. Abhyankar agreed and appreciated the practice of conduction of BoS meeting.

It was resolved to recommend to Governing Body for its final approval.

Item **AC 6:17** **To take the review of academic activities (Parents Feedback, Academic Calendar etc.).**

Resolution **AC 6:17** It was briefed in the meeting that, following activities were undertaken in the institute.

- (a) Parents Meet of F.Y. B.Tech was held on 02/01/2017, the report of parents feedback was briefed in the meeting. It was for implementation of academic calendar, regularity in conduction of theory and practical classes, scheme and syllabus and teaching learning process, co-curricular activities, examination scheme and exam conduction, discipline in the campus, timely receipt of feedback of ward, transparency in evaluation of all tests. Declaration of results, grievances handling, overall academic standard, overall institute performance, overall development of ward and Campuspreneur programme. The parent feedback for the above parameters - excellent 220, good 405, Satisfactory 160 and Poor 22. The members noted the contents and suggested that, out of 400 students only 75 parents were present in the meeting. This attendance should be increased in next meeting.
- (b) The academic calendar and planner put up in the meeting. The members appreciated the contents of it.
- (c) Students participation in NSS, Kite Flying and State Level Drama Competition (Student won 04 prizes in Drama Competition).

The members suggested to craft the name and fame of our institute as role model institute to others.
